- Just speak about the 4 priorities for Public Health and link to people with LD
- Lots of interesting information and nice style of presenting.

2 How we can help:

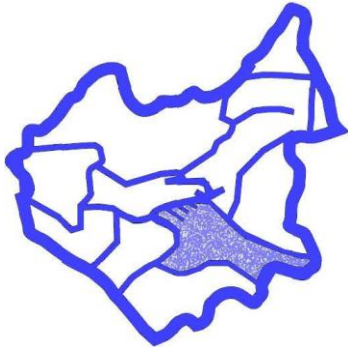
- The Better Health Sub Group could help speakers to understand the issues for people with Learning Disabilities and how to make the messages easier to understand.
- Provide local information about health needs and inequalities for people with Learning Disabilities
- We have information from health checks
- We need to make sure doctors know about the work of the specialist Learning Disabilities health services and therefore know their own role
- You said that in the JSNA we don't have much idea about how the health priorities impact on people with Learning Disabilities in Leicestershire and asked if we would be able to help you find out. We can do this with you if you support us. This will help you find out whether there is a difference between the numbers of people with Learning Disabilities who smoke, drink too much alcohol or suffer obesity against the number of people without Learning Disabilities who have these problems.

3 Anything else we would like to share with you:

We can make sure specialist health services work with Public Health to make things more accessible to people with Learning Disabilities.

- Training of staff needs to involve people with Learning Disabilities and their families and carers.

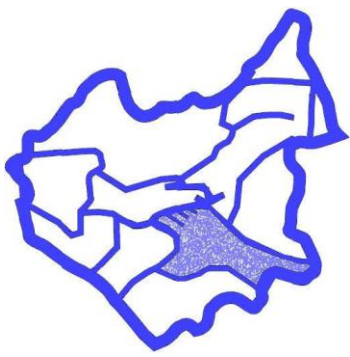
3 Anything else we would like to share with you:

- We need to know when you will be in the area where we live and where you will be doing it so that we can tell other people

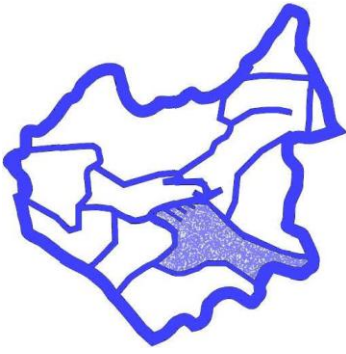
- People with LD can also help to explain what happened to them
